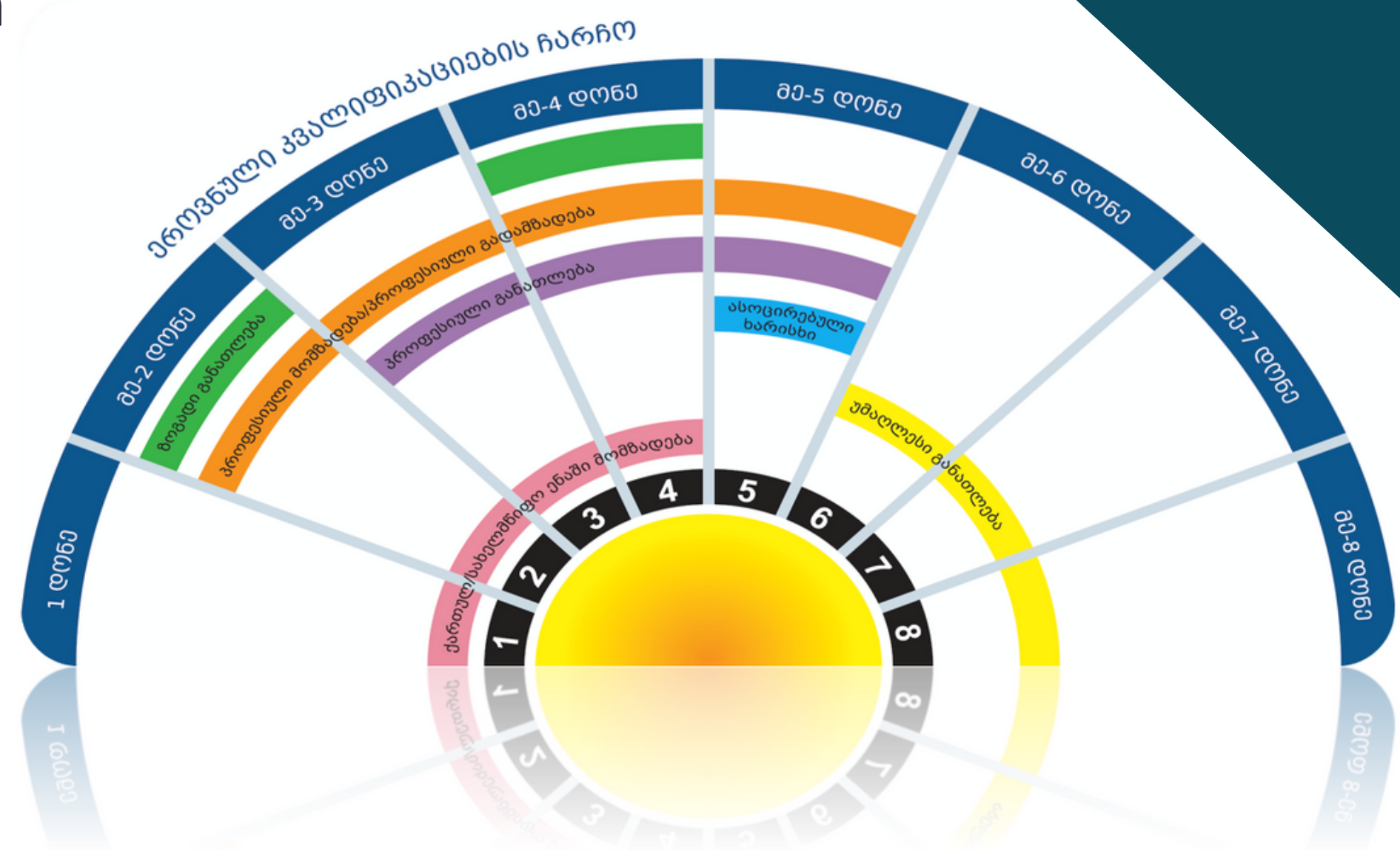

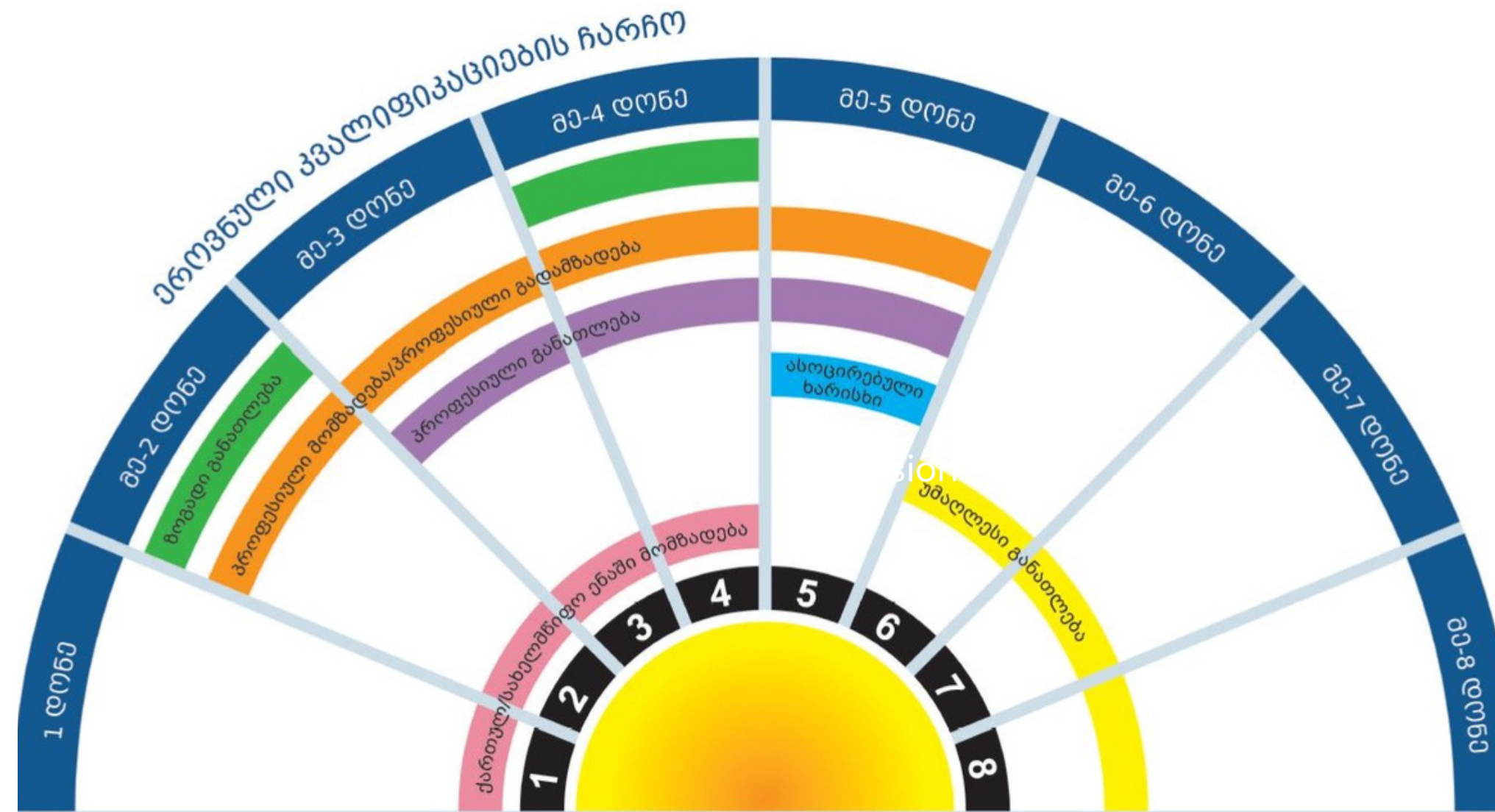

Implementation of Bologna Key Commitments in Georgia

Key Commitment 1

(a three-cycle system compatible with the overarching Qualifications Framework of the EHEA and first and second cycle degrees scaled by ECTS) - Georgia moved to three cycle system in 2007, Learning Outcome Approach, ECTS

Key Commitment 2

Lisbon Recognition Convention (LRC) and Diploma Supplement - Georgia ratified Convention in (1999)

Key Commitment 3

Quality Assurance according to the Standards and guidelines for Quality Assurance in the EHEA (ESG) - Georgia started the implementation of ESG 2015 in 2017 (2nd HE QA Reform Phase)

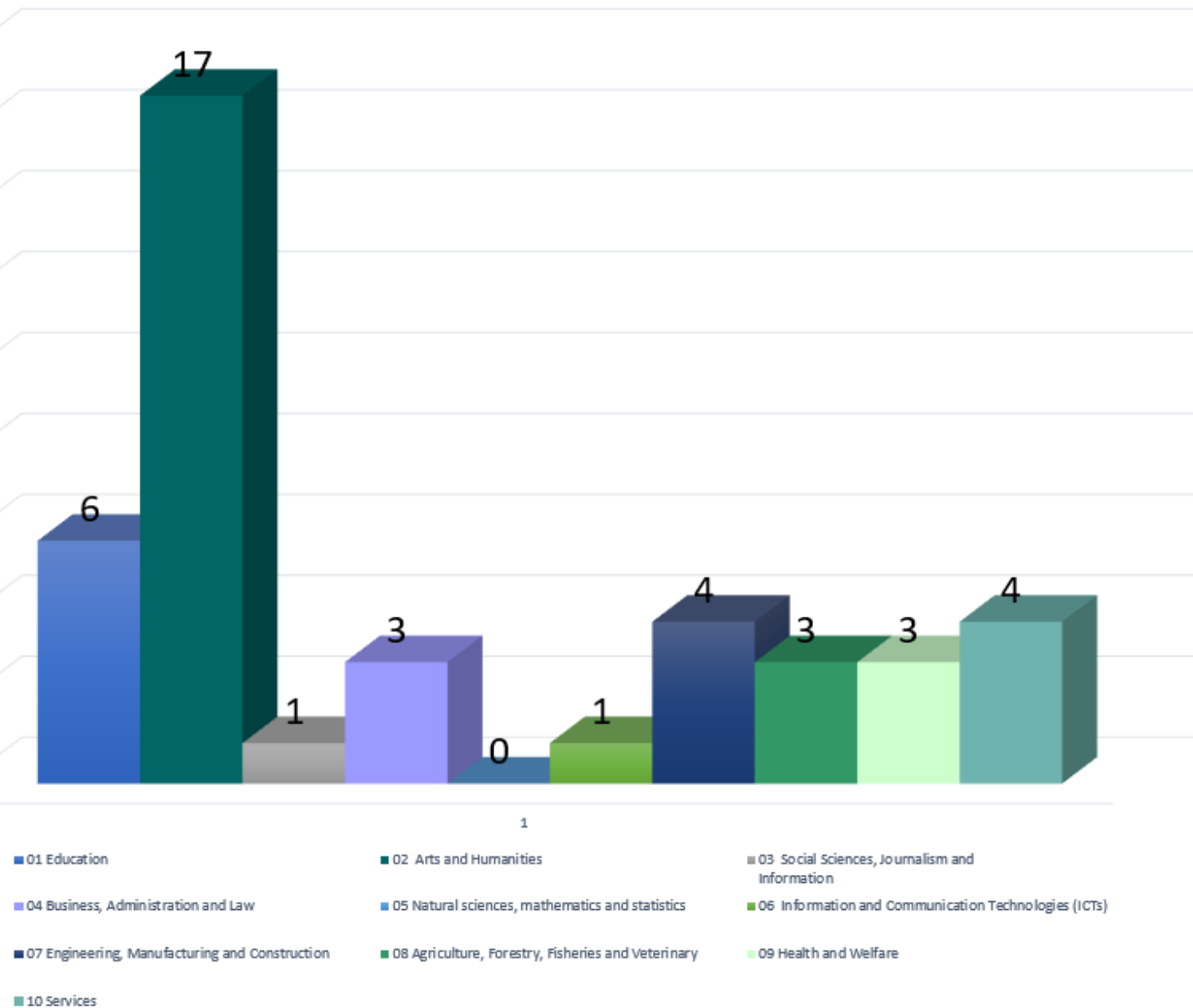

NEW GNQF Implementation from 2019 to present

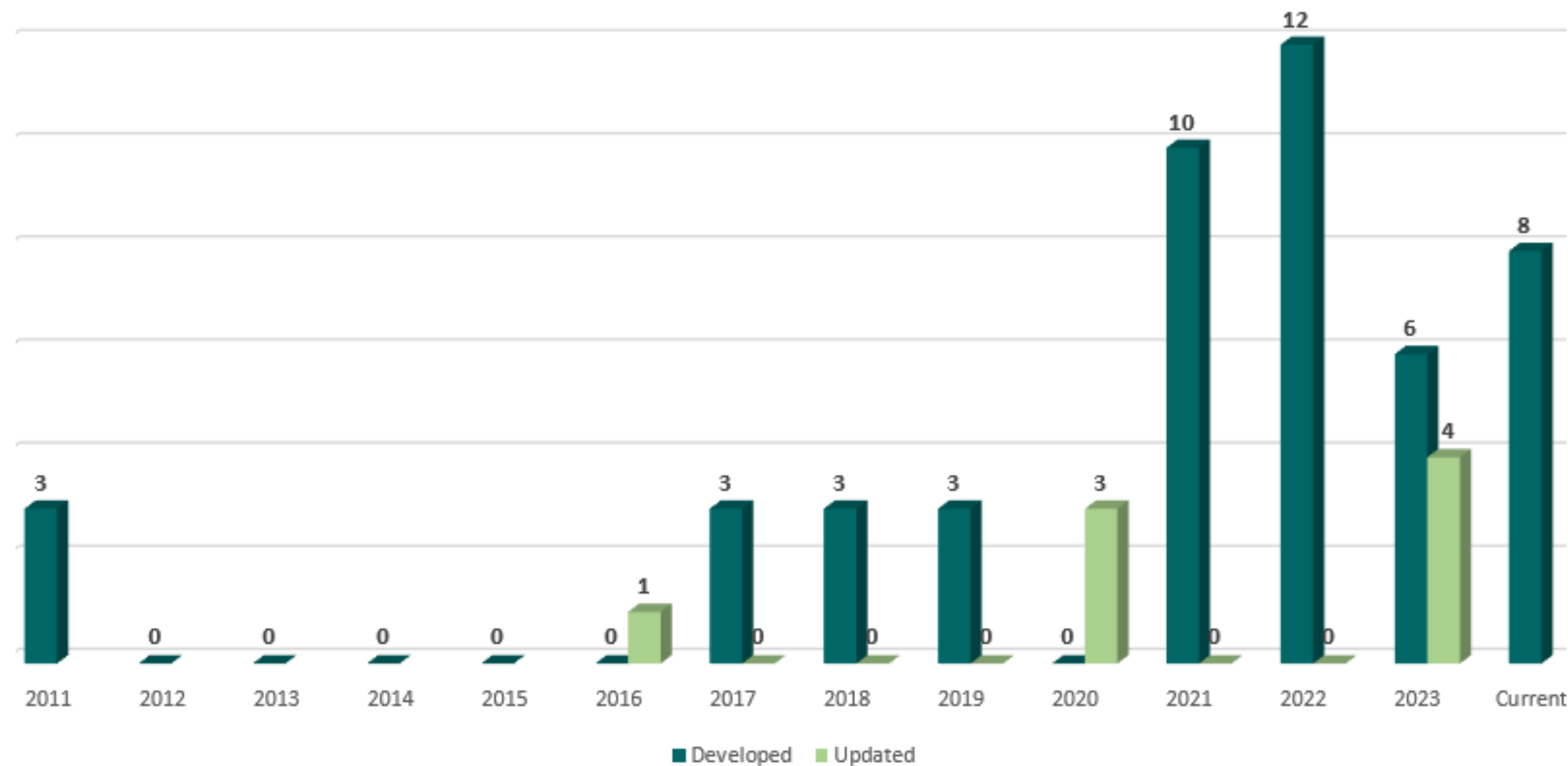
- GNQF management and evaluation system was created – GNQF Advisory Board
- Alignment process of all HE programs to new GNQF
- Cluster Accreditation of HE programs was initiated (2022)
- HE Benchmark development in line with the Cluster Accreditation Plan
- Development of the GNQF Digital Registry

Some Trends: (1) Stakeholders' Engagement in HE Benchmark Development/Revision is increasing (2) Detailed Fields of Studies have been developing

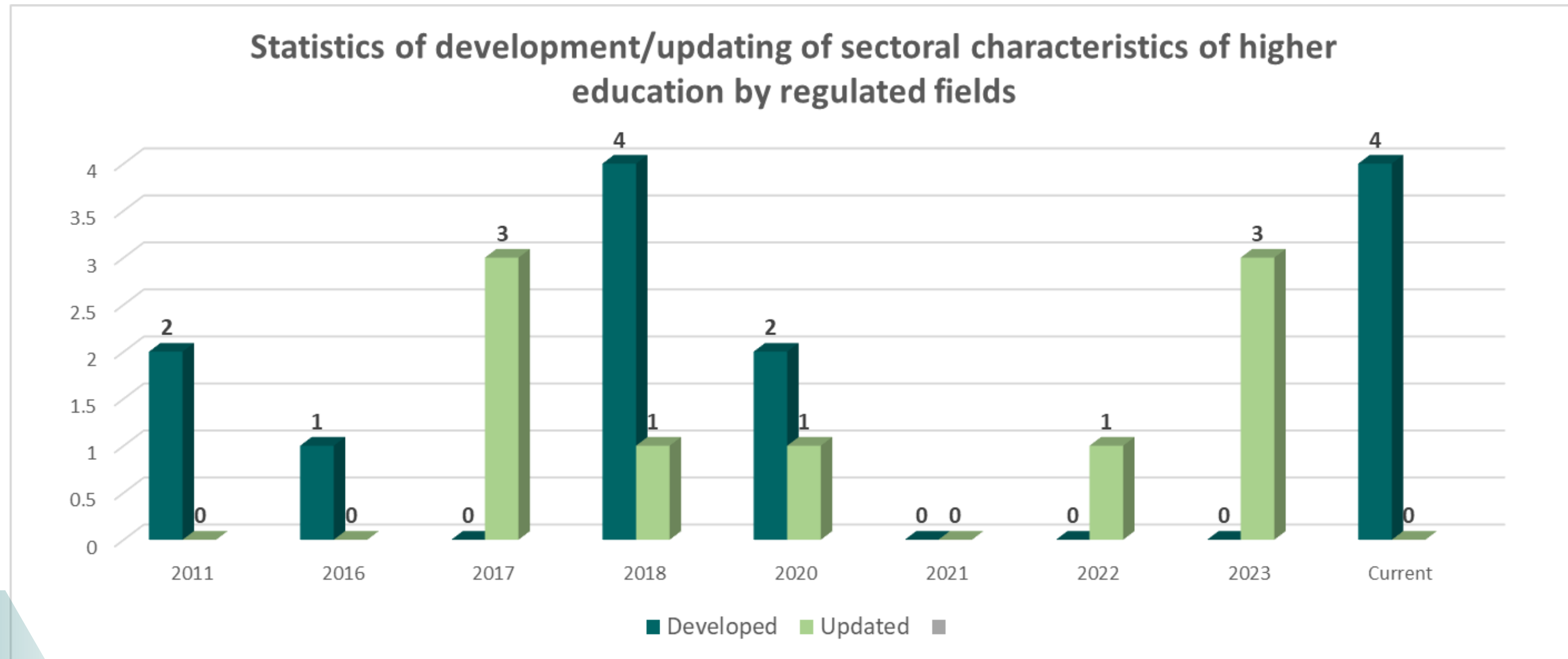
Sectoral Standards of Higher Education according to the broad field of study of ISCED-F 2013



Development and updation of sectoral standards of higher education by years

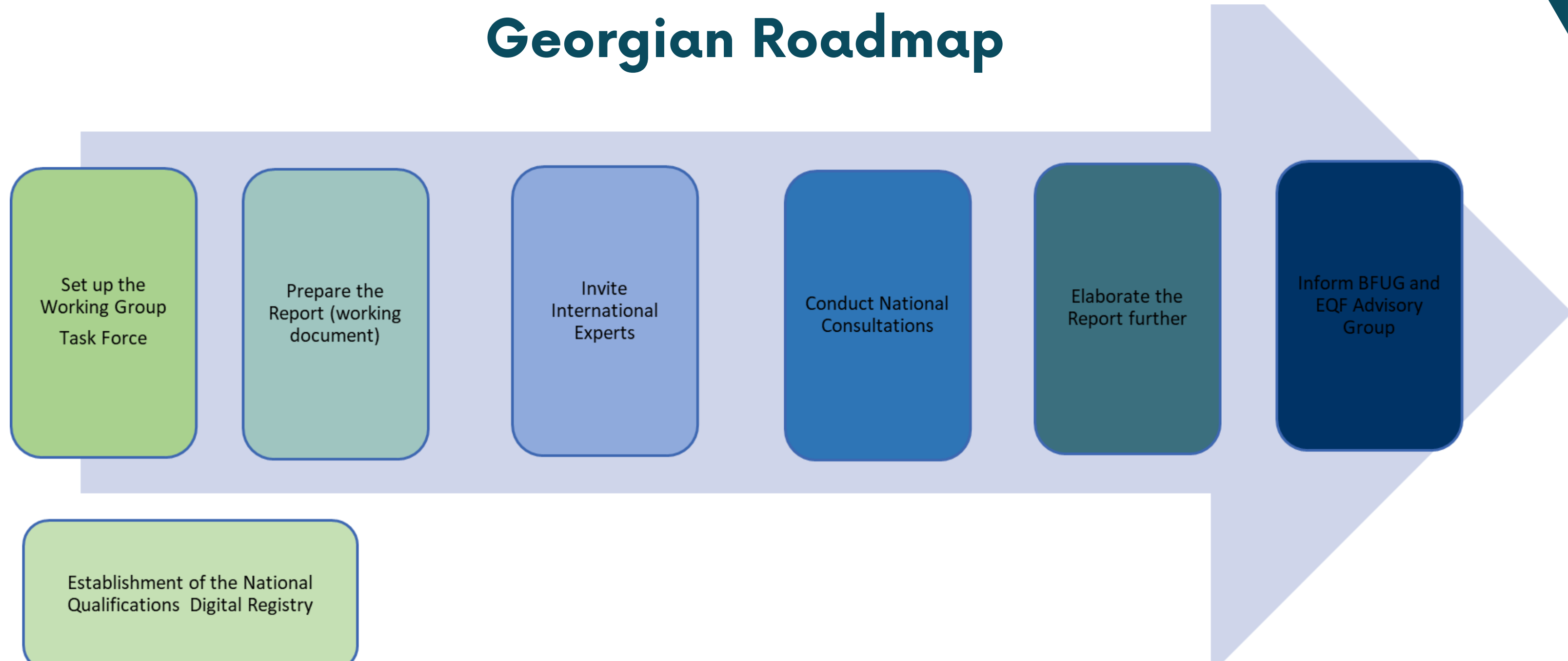


Key Trends: Sectoral Benchmarks Development in Regulated Fields is getting more Importance from Line Ministries and Stakeholders
