A modular study course (microcredential) ensuring the acquisition of a qualification in **Financial** Management

- During the study process, BASBF students have the opportunity to acquire certificate with a qualification of a Financial manager on completion of the Module
- The Module coressponds to micro-credential concept
- Currently Module is integrated into a Bachelor study program
- The Module can be regarded as alone standing study module accessible to a wide public who have appropriate prerequisites

A modular study course (microcredential) ensuring the acquisition of a qualification in **Financial** Management recognized in Latvia and UK

- The Module is integrated into the Bachelor's Study program" Finance" which differentiates the Bachelor's study program" Finance" from other bachelor study programs
- The Module has been developed as a customized Module that complies with international quality standards approved by SQA, UK
- During the study process, the students have the opportunity to acquire SQA,
   UK certificate with a qualification of a Financial manager
- A customised qualification award, e.g. Financial management, is accredited by SQA, Scotland and rated on the Scottish Qualifications Framework, Level 9, UK, LQF Level 6
- The Module is available to students studying at all study programs at BASBF

#### Who can take the micro-credential qualification at BASBF

- Students studying at the Bachelor degree study program offered at BASBF
- Students specialized in finance, risk management and insurance
- Students of a joint interdisciplinary study program implemented together with Riga Technical University Financial Management Information Systems
- Students studying at HEIs who have required prerequisites can take the Module leading to a qualification of a Financial Manager
- Any candidate who is interested to acquire a new qualification have the opportunity to study the Module, after a successful assessment, get a qualification of a Financial management
- Available as alone standing Module in future for any candidate from EU and beyond

#### Benefits of the acquisition of the qualification

For BASBF graduates additional qualification in Financial Management to a Bachelor's degree and a qualification of a financier

For a joint degree students who study information technology and acquire engineering qualification – also get a qualification in Financial Management

A graduate of a financial analyst can acquire also a qualification of a Financial Manager

## Candidates who expressed interest to acquire Financial Management qualification

- Over the years the BASBF students studying at Risk Management and Insurance study program, Business Administration
- Students of a joint study program implemented by BASBF and together with Riga technical University Financial Management Information Systems have the opportunity to receive in addition to the engineering qualification, SQA certificate with a qualification of a Financial manager
- In addition, the interested persons who were not BASBF students studied the Module to acquire knowledge and skills they need and got BASBF certificate which is a microcredential

#### **Promotion and Recognition for BASBF**

- BASBF is recognized as an issuer of international qualification, namely SQA certificate in Financial Management
- In 2016 BASBF was praised for its bold attitude towards curriculum development offering flexible approach to teaching and learning and recognized in the international category receiving a prestigious annual "SQA Star Award" from SQA, UK

#### Practical infomation on the micro-credential certificate

- The learning outcomes must be formally assessed to determine whether the candidate is competent for the award
- The Module and the study course includes formal teaching, individual study time, practical activities and assessment
- From the point of view of a legislation the Law on Higher Education Institutions in Latvia, Chapter I, General Provisions stipulate that a study module is a component of the study program which is created by combining study courses or parts thereof, which have a common goal and achievable learning outcomes

#### **Quality Assurance**

- As the Module is a part of study program it is accredited within the study direction: Economics
- As the Module complies with international quality standards approved by SQA, UK, it is accredited by UK

## Special criteria required by SQA UK for the delivery of the Module include

- The study agreement is drawn up within one week after the deadline of enrolment in the Module
- The records of candidates are done by SQA coordinator at BASBF
- SQA coordinator at BASBF prepares the following files: SQA candidates (applications and agreements), SQA student assessment materials, copies of certificates
- An independent internal verifier from BASBF is nominated who reviews and cross marks assessment and final exam
- SQA coordinator at BASBF keeps the records of exams and their schedules
- SQA coordinator at BASBF communicates electronically with SQA centre
- The candidates endorse the transfer of data to SQA by their signature in the agreement

# Future developments of micro-credentials at BASBF

- To offer the existing Module as a microcredential to a wider public within Latvia and beyond
- To offer the existing Module in person and at a distance course
- Information to be included in the course catalogue and in other online platforms
- Future plans at BASBF include the development of other micro-credential offers
